- a) Gifts of \$50,000 or more have the option to become a 'Named Fund', with distributions and the fund value reported back to the donor's family each year.
- b) Gifts under \$50,000 can be directed to either the Waikato Future Fund (Momentum Waikato's endowment fund) or into an existing Today Fund for direct distribution to a charity or project of the donor's choice.

3. Intended Beneficiaries

- a) These beneficiaries must operate for a charitable purpose as defined and recognised by the Charities Commission and the Inland Revenue Department. If your client nominates a nationwide charity, please specify if they wish their distributions to be used in the local region.
- b) If your client wishes, distributions may be split, e.g. 75% to a Today Fund (to be immediately directed to a charity of their choice or one of the 'Vital Signs' pillars) and 25% invested into the Waikato Future Fund (with the resulting income likewise directed to a charity of their choice or one of the 'Vital Signs' pillars).



Amending Your Client's Will

| Nothing can happen until provision has been made in your client's Will to nominate Momentum Waikato as a beneficiary. The suggested wording is as follows: | |

| Community Trust to fulfil the donor's/trust's wishes, as agreed between both parties." | |

| Once your client's Will has been fully actioned, a signed copy of their instructions to Momentum Waikato is to be held by both parties. | |
| Momentum Waikato will also need to receive a signed copy of the 'Bequest Wishes - under \$50,000 form, or the 'Memorandum of Wishes for Bequests \$50,000+' form, or the 'Trust Transfer Form', which will confirm and summarise your client's intent for Momentum Waikato. | |
